Group 1 corresponds to five athletes appointed by the International Olympic Committee's (IOC's) and International Paralympic Committee's (IPC's) Athletes' Commissions (ACs). Group 2 corresponds to eight athletes elected by the ACs of International Federations. Group 3 corresponds to seven other athletes selected by an appointment panel made up by a majority of athletes, to fill skills and diversity gaps.

<sup>&</sup>lt;sup>5</sup> Yujiao Tan was appointed by the IPC AC in late November 2024 to fill the vacancy on the Athlete Council Group 1 due to the departure of Jitske Visser, whose term ended on the IPC AC at the Paris Paralympic Games.
